Wedding Ceremony Terms and Conditions

Our wedding that will help you plan, create, write, and conduct your personalised wedding ceremony for the following fee:

- 2022 ceremonies – £500.00 plus travel costs beyond 30 miles at 45p per mile.
- 2023 ceremonies – £550.00 plus travel costs beyond 30 miles at 45p per mile.
- 2024 ceremonies – £575.00 plus travel costs beyond 30 miles at 45p per mile.

We agree to pay £200.00 at the time of booking to secure the date, as we know that Forget Me Not Celebrant may have turned down other work to save the date exclusively. On paying the booking fee, we acknowledge that we have read, understood, and agree with these terms and conditions. We know that there is a 14 day 'cooling off' period and all cancellations should be sent in writing to Forget Me Not Celebrant email.

Rehearsals

We acknowledge wedding rehearsals need to be arranged within 14 days of booking to avoid disappointment and we agree to pay an additional £100.00. plus travel for this service.

Communication

We agree to work closely with Forget Me Not Celebrant and respond promptly to questions relating to planning and writing of the wedding ceremony.

Cancellation

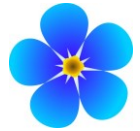
We understand if Forget Me Not Celebrant cannot perform our ceremony because of illness or any other unavoidable situation, they will do her very best to arrange a replacement Celebrant and share ceremony details.

Changes to the booking

We understand that Forget Me Not Celebrant performs other ceremonies and any changes to the booking may create a conflict with her schedule. We agree to email Forget Me Not Celebrant with any changes to the booking at our earliest convenience and Forget Me Not Celebrant will accommodate changes whenever possible, however they cannot be guaranteed as they may have another booking.

Marriage Law in England

For marriage ceremonies to be recognised by law in England, you must also fulfil the legal requirements of a Notice of Marriage and Civil Partnership (there is a cost per person). This must be completed at a Registry Office at least 3 months prior to the date of your ceremony, but no later than 30 days. Please don't hesitate to contact Forget Me Not Celebrant if you have any questions or concerns.

Note: a Celebrant cannot legally marry you. The celebrant can officiate at your wedding ceremony. The legal paperwork should be done in advance of your wedding ceremony. For further information, please speak to us.

A wedding ceremony run by Forget Me Not Celebrant is open to all beliefs, accepting and respecting all with a forgiving heart which leads to a life of simplicity, peace, and love. Forget Me Not Celebrant's promise is to work in integrity, love and acceptance and write a bespoke ceremony which reflects your wishes, values, and beliefs.
